London/Hanover, 10 April 2008. S-Group Capital Management Limited, Cyprus ("S Group") and TUI Travel PLC ("TUI Travel") announce that they have signed a Memorandum of Understanding ("MOU") to jointly develop TUI Travel's Russian and CIS* leisure tourism presence.

Under the terms of the MOU, a joint venture company will be established as the investment vehicle of the parties with the objective of becoming a leading player in the fast growing Russian and CIS leisure tourism markets.

"I am delighted we have taken this important step towards establishing the joint venture company which will focus its business on the fast growing Russian market. We believe it offers significant opportunities that we will be able to explore jointly with our partner", said Alexey Mordashov.

Commenting on the co-operation Peter Long, CEO of TUI Travel said "I am very excited by the huge growth potential of the Russian and CIS tourism markets and I am delighted to join forces with such a substantial organisation as S Group to develop our presence in the region."

Among other positions he is the CEO and major shareholder of OAO Severstal, an international, vertically integrated steel producer with a listing on the Russian Trading System and the London Stock Exchange. Severstal has a successful track record of acquiring and integrating high-quality assets in North America and Europe. In 2007, Severstal produced 17.5 million tons of steel. Revenues were \$15.2 billion and EBITDA was \$3.7 billion.

The CIS comprises of eleven former Soviet Republics: Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Ukraine and Uzbekistan.
