



**Disclosure pursuant to section 26, paragraph 1, sentence 1
of the German Securities Trading Act (WpHG)**

Barclays plc, London, United Kingdom, informed us on 08 August 2011 pursuant to section 21, paragraph 1 WpHG in its own name as well as on behalf of its subsidiaries Barclays Bank plc, London, United Kingdom, and Barclays Capital Securities Ltd, London, United Kingdom, that they reduced their voting rights in TUI AG, Hanover, Germany on 04 August 2011 below the thresholds of 5% and 3% and at that point in time held 1.58% (3,978,789 shares). All voting rights were attributed to Barclays plc pursuant to section 22, paragraph 1, sentence 1 no. 1 WpHG via its subsidiaries Barclays Bank plc and Barclays Capital Securities Limited, and to Barclays Bank plc pursuant to section 22, paragraph 1, sentence 1 no. 1 WpHG via Barclays Capital Securities Ltd.
